These are based on a computer evaluation of the standard of participant.

If there are other circumstances that you believe warrant the ITF Seniors Committee to consider your tournament for an upgrade, please send an official letter with your renewal application, attaching any supporting documents and a letter of endorsement from the Seniors Association in your country.

SANCTION FEES:

The following Sanction Fees will be charged to all ITF Seniors Circuit tournaments for 2009.

Grade 1 – US \$650 ; Grade 2 – US \$435 ; Grade 3 – US \$325 ; Grade 4 – US \$220 ;

Invoices will be sent to National Associations or National Seniors Associations. Each association is expected to collect sanction fees for events in their country and make one payment to the ITF.

These fees apply only to those tournaments reconfirmed as ITF Seniors Ranking Tournaments in 2009.

"We agree to abide by the "Regulations for the Organisation of Seniors Tournaments" as stated in the ITF Seniors Regulations and to pay the required sanction fee if approved as an ITF Seniors Ranking Tournament."
